At 1:30 p.m., the Commission met with Kathleen Lear, Comptroller, of the Missouri State Public Defender's office. Ms. Lear presented an addendum to the lease between Lessor - Crist Properties, LLC and Lessee - the Counties of Adair, Schuyler, Scotland, and Knox for an additional three years over what is now in effect. The cost of rent for one year will increase to \$18,000 for the above Counties. Adair County's 64.89% portion will increase to \$11,680.29 or quarterly payments of \$2,920.07. The Public Defender's office is asking for renovations to the building in order to accommodate staff that has grown by more than 50% since the execution of the original lease. The increase will begin in January, 2015.

Commissioner Pickens, Commissioner Adams, and Commissioner Thompson all signed the lease. A signed copy with all parties involved will be returned to the County at a later date.

The Commission spent the rest of the day attending to County business.

The Adair County Commission adjourned at 4:00 p.m. on July 29, 2014.

1) All invoicing and reporting will follow the guidelines and restrictions as set out in the attached statement of work. By signing this form you agree to abide by the terms set forth in the statement of work and comply with all requirements therein.	
2) All payments shall be considered provisional and subject to adjustment within the total estimated cost in the event such adjustment is necessary as a result of an adverse audit finding against the Collaborator.	
3) Matters concerning the technical performance of this agreement, no cost extensions, a request or negotiation of any changes in terms, conditions, or amounts, and any changes requiring prior approval, should be directed to University's project director as noted in the signature block of this form. Any such changes made to this agreement require the written approval of each party's Authorized Official.	
4) Each party shall be responsible for its negligent acts or omissions and the negligent acts or omissions of its employees, officers, or directors, to the extent allowed by law.	
5) Either party may terminate this agreement with thirty days written notice to the appropriate party's Administrative Contact, as shown in Attachment 1. If applicable, University shall pay Collaborator for termination costs as allowable under OMB Circular A-87, OMB Circular A-21, OMB Circular A-122 or the Federal Acquisition Regulation, whichever applies.	
6) This agreement is subject to the terms and conditions of the Prime Award, Project No. 14-156-AJ-002, and other special terms and conditions.	
7) This agreement shall be governed and construed in accordance with the laws of the State of Missouri.	
8) By signing below Collaborator certifies and assures:
