

ADAIR COUNTY COMMISSION MINUTES
WEDNESDAY, APRIL 5, 2017
3RD DAY APRIL REGULAR

The Adair County Commission convened at 8:30 a.m. on April 5, 2017 in the Courthouse at Kirksville. Commissioner King and Commissioner Thompson were present. Commissioner Thompson will be acting Presiding Commissioner during the absence of Presiding Commissioner Pickens.

Adair County Clerk, Sandra Collop, reported successful unofficial results for candidates and questions for the April 4, 2017 Adair County Municipal Election. Successful candidates for R-1 Novinger School District Board Members were Christina Farrell – 111, Kathryn Magers – 90, and Troy Smith – 87; for R -2 Brashear School District were Alissa Garlock – 125, Keith L. Turner – 113, and Sara Erwin – 112; Kirksville R-3 School District Board Members were Nan Davis – 1383, Jeremy James Houser – 1329, and Adam Michael Moore – 1242; LaPlata R-2 School District Board Members were Amy B. Crawford – 19, Kevin Pipes – 19, and Tina M. Belfield – 15; Mayor for City of Greentop, Adair was Debbie Pearson – 4; Mayor for City of Novinger, Adair was Jeffrey L. Dodson – 46; Alderman At-Large for City of Greentop, Adair was Justin Ray – 4 and Kim Veatch – 3; Alderman At-Large for City of Novinger, Adair was Janice Pearce – 45 and Rick Schmidt – 39; Council Member for City of Kirksville, Adair was Richard “Rick” Steele - 1,704 and Jerry Michael Mills – 1547; Proposition A for City of Brashear, Adair: “Shall the Fire Protection Levy remain at \$0.30 for the next four years?” – YES – 35 and NO – 0; Question for City of Kirksville, Adair - Shall the City of Kirksville, Missouri impose a sales tax of one-half of one percent (1/2 of 1%), for fifteen years, for the purpose of funding City parks and recreation? The City intends to use this sales tax solely for local parks of the City, in order to construct, maintain, improve and manage parks, trails, playgrounds, park parking lots, bathrooms, aquatic facilities, cemetery, and other natural lands and facilities primarily used for recreational purposes. – YES 1,490 and NO - 679; Village of Gibbs for Board of Trustees were Burton Keller (Write-In) – 6, Andy Heimer (Write-In) – 2, Anthony Shaw (Write-In) - 2, Clifford Wagster (Write-In) - 2, and Harold Kissell (Write-In) - 2; and Village of Millard for Board of Trustees were Felicia Scott – 4, Tim Scott – 4, and Tina Yadon (Write-In) - 2.


At 10:45 a.m., the Adair County Commission adopted the following resolution:


