- 2. Calling Teladoc directly at 1-800-835-2362.


Teledoc is a simple new way to access qualified doctors and is a convenient and affordable option for quality healthcare.

Can Employees Make Insurance Changes After Open Enrollment?

The Answer Could Be...Yes



Employees are unable to change their insurance coverages for another year unless they qualify for a special enrollment period. A special enrollment period can apply for employees during qualifying life events.

Examples of qualifying life events include:

- Lost of health coverage
 - * Including job-based, individual, and student plans
 - * Losing eligibility for Medicare, Medicaid, or CHIP
 - * Turning 26 and losing coverage through a parent's plan
- Changes in household status
 - * Getting married or divorced
 - * Having a baby or adopting a child
 - * Death in the family



Employees only have **30 days** following a qualify life event to submit a request for a special enrollment period. If employees are unsure if they qualify for a special enrollment period or need an *Event Change Form* to change insurance coverages due to a qualify life event contact Human Resources at (660)234-7914 or email at hkelley@adaircomo.com

Reimbursable Deductible Allowance (RDA) Benefit

EMPLOYEES...ARE YOU GETTING YOUR CASH BACK?

This is an included benefit...all employees with GBS coverage can take advantage of this benefit!

Through RDA, a portion of out of pocket expenses applied to your deductible and co-payments made throughout the year can be reimbursed. *Employees and dependents covered under any of the Medical Insurance Plans can be reimbursed up to \$500 each year (Maximum \$1000 for a family)*.

To receive a reimbursement, employees simply submit payment receipts with the Explanation of Benefits (EOB) statements from the insurance company along with a completed RDA Claim Form. Human Resources can submit claims on behalf of employees or employees can submit claims directly to GBS either by mail, fax, or though employee's online GBS account.

Human Resources can help employees by...

- 1) Printing a list of all individual medical claims eligible for the RDA benefit
- 2) Providing RDA claim forms and EOB Statements
- 3) Submitting RDA claims

Flexible Spending Account (FSA) Information

You have until December 31, 2019 to spend any money left in your Flexible Spending Account (aka Flexible Benefit Account). FSA balance information can be found on your GBS online account or you can call GBS at (800)995-3569 for account information. FSA debit card swipes will be accepted until midnight on December 31, 2019 and paper FSA reimbursement forms will be accepted until March 31, 2020 for any 2019 expenditures.

2019 Flexible Spending Account money cannot be carried over into 2020.



Two Adair County Officials Get Elected To Executive Boards

Lori Smith, Adair County Treasurer, was elected to serve as the Treasurer on the Missouri Association of Counties (MAC) Executive Board. Her term will begin January 1, 2020. MAC includes 1,400 county elected officials and is composed of presiding and associate commissioners, county clerks/election authorities, recorders, auditors, collectors, prosecutors, sheriffs, assessors, treasurers, public administrators, circuit clerks, and coroners. MAC is a lobbying alliance that represents these local government elected officials, all of whom work to improve services for Missouri taxpayers and citizens.

Mark Thompson, Adair County 2nd District Commissioner, was elected and is currently serving as Secretary on the County Commissioners Association of Missouri (CCAM) Executive Board and served a previous term as Board

Treasurer. CCAM association membership consists of 330 Missouri county government commissioners. CCAM creates a close and cooperative relationship among the commissioners of the state. It provides an opportunity for its members to become better-informed about the powers and duties of their offices as described by state statutes and works to investigate legislation relating to the office and responsibilities of county commissioners.

Assessor Maupin also currently serves as the President of the MSAA and presided over the annual conference.
