2022 Open Enrollment November 15-19, 2021

Group Benefit Services (GBS) Open enrollment is November 15-19, 2021. You will get the chance to make changes to your elected benefit coverages for yourself, your spouse, or dependents regarding:

- Dental
- Vision
- Dependent Life Insurance
- ◆ Flexible (Spending) Benefit Account (FSA)

For Coverages Effective January 1, 2022.

Open enrollment details, benefit change forms, and FSA paperwork will be provided to employees on November 12, 2021.

New premium amounts for 2022 will begin on payroll period #24 (December 3, 2021).

Flexible Spending Account (FSA) Information

You have until December 31, 2021 to spend any money left in your Flexible Spending Account (aka Flexible Benefit Account). FSA balance information can be found on your GBS online account or you can call GBS at (800)995-3569 for account information. FSA debit card swipes will be accepted until midnight on December 31, 2021 and paper FSA reimbursement forms will be accepted until March 31, 2022 for any 2021 expenditures.

2021 Flexible Spending Account money <u>cannot</u> be carried over into 2022.
