Covered Expenses

- a) **Eye Refractions.** Eye refractions, eyeglasses, contact lenses, or vision examination for prescribing or fitting eyeglasses or contact lenses, and
- b) **Recommended.** Recommended and approved by a physician or optometrist.

Exclusions and Limitations (Note: this is not a comprehensive list of exclusions or limitations)

Benefit Limitations. Participants can use the benefit to secure either eye glasses with frames or contact lenses (not both).

Greater Coverage. Any charges that are covered under a medical or health plan that reimburses greater than this plan amount.

Radial Keratotomy. Radial keratotomy or other plastic surgeries on the cornea in lieu of eyeglasses.

Safety Googles or Sunglasses. Charges for safety googles or sunglasses.

Employees, did you know?

Participants in the GBS Medical Plan can get reimbursed up to \$100 for basic eye exam costs annually without being enrolled in the supplemental vision coverage. 2021 Open Enrollment Coming Soon

Group Benefit Services (GBS) Open enrollment will be November 9-20, 2020. You will get the chance to make changes to your elected benefit coverages for yourself, your spouse, or dependents regarding:

- ♦ Medical/RX
- Dental
- ♦ Vision
- Dependent Life Insurance
- ◆ Flexible Spending Account

For Coverages Effective January 1, 2021

Employees

You will receive an information packet in November so that you can make informed decisions about your 2021 Insurance Coverages for Medical/RX, Supplemental Dental, Supplemental Vision, Supplemental Dependent Life Insurance, and Flexible Spending Accounts.



Public Pension Retirement Planning

You need to start your retirement application paperwork 30-90 days prior to your planned retirement date.

Once you submit your application, LAGERS and CERF will contact you and you will need to be able to answer the following questions:

1) What type of monthly benefit payments will you want to receive?

Below is a summary of retirement payment options (Note: Most payment option selected **cannot** be changed once a monthly benefit begins):

- Single Annuity: single payments made only to the member -this option provides the highest monthly lifetime benefit to a member
- Joint Annuity: sharing your retirement benefits with a beneficiary/spouse- with a reduction in life time benefits to the member (Note: You cannot change the beneficiary/spouse once you start receiving benefits)
- 10 Year Certainty: Guarantees 120 payments- the member will still receive a lifetime benefit (at a reduced amount) but if the member passes away within 10 years of retiring any remaining payments of the guaranteed (120 payments) can go to a designee (Note: You can change the beneficiary (designee) on this option after receiving benefits)
- Partial Lump Sum (LAGERS only): 2 years of benefit payments immediately-followed by a reduced monthly lifetime benefit to the member
- 2) Do you want your retirement check direct deposited?
- 3) Will you want State and Federal taxes withheld from your benefit payments each month (consulting with a tax professional might be a good idea prior to making this decision)?

Missouri's Secretary of State Jay Ashcroft Visit The Courthouse

Missouri Secretary of State Jay Ashcroft visited the Adair County Courthouse on Wednesday September 23, 2020 to meet with Adair County Clerk Sandy Collop and to check-in on voting preparations for the 2020 General Election.

Absentee voting for the General Elections began Tuesday September 22, 2020 at the Adair County Annex Building on 300 North Franklin Street and will continue until 5 p.m. Monday November 2, 2020.

Residents can request an absentee ballot from Clerk's Office in person, by mail, by fax or by email. Mail in or faxed absentee ballots requests or applications must be received by the election authority no later than 5 p.m. on Wednesday October 21, 2020.

Absentee voters must provide one of the following reasons for voting absentee:


- Absence on Election Day from the jurisdiction of the election authority in which such voter is registered to vote
- Incapacity or confinement due to illness or physical disability, including a person who is primarily responsible for the physical care of a person who is incapacitated or confined due to illness or disability
- Religious belief or practice
- Employment as an election authority, as a member of an election authority, or by an election authority at a location other than such voter's polling place
- Incarceration, provided all qualifications for voting are retained
- Certified participation in the address confidentiality program established under sections 589.660 to 589.681 because of safety concerns
- For an election that occurs during the year 2020, the voter has contracted or is in an at-risk category for contracting or transmitting severe acute respiratory syndrome coronavirus 2 (COVID-19)
- Voters who are considered at-risk for contracting or transmitting COVID-19 are those who:
 - Are 65 years of age or older
 - Live in a long-term care facility licensed under Chapter 198, RSMo.
 - Have chronic lung disease or moderate to severe asthma
 - Have serious heart conditions
 - Are immunocompromised
 - Have diabetes
 - Have chronic kidney disease and are undergoing dialysis
 - Have liver disease




