

**ADAIR COUNTY COMMISSION MINUTES
WEDNESDAY, OCTOBER 1, 2014
1ST DAY OCTOBER REGULAR**

The Adair County Commission convened at 8:30 a.m. on October 1, 2014 in the Courthouse at Kirksville. All Commissioners were present.

The Adair County Commission hosted the 2014 fall meeting of the Commissioners and Clerks for the Northeast District of Missouri. Representatives from Audrain, Chariton, Clark, Knox, Lewis, Lincoln, Macon, Marion, Monroe, Montgomery, Pike, Ralls, Randolph, Schuler, Scotland, and Shelby Counties were represented. Warren County was unable to attend.

The meeting was held at the Northeast Missouri Fairgrounds in Kirksville. The morning began at 9:00 a.m., with registration and coffee and donuts. The welcome and introduction was conducted by Mark Thompson, Second District Commissioner. After the Pledge of Allegiance, the group entertained several speakers. These included Dick Burke of the Missouri Association of Counties speaking on current legislative issues; Mike Hall from the State 911 Advisor Committee speaking on current 911 issues; Paula Gough of the Missouri Department of Transportation (MoDOT) speaking on current MoDOT issues, and Dr. Jack Magruder, former President of Truman State University and Andrew Taylor Still University plus many other accomplishments. Mr. Magruder spoke on "How Kirksville has impacted Northeast Missouri".

At 12:00 p.m., Adair County Assessor, Donnie Waybill, gave the invocation and lunch was provided. The afternoon was spent with everyone attending breakout session for the Commissioner and the County Clerks.

The Adair County Commission thanked all who attended the event.

At the request of Matt Holt, Court Services Administrator, Commissioner Adams moved to transfer funds from the Juvenile Justice Center account (907-5-003-902.000) in the amount of \$5,000.00 to the Juvenile Grant Operations account (909-4-000-700.100) so they could make payroll for the two week period ending September 27, 2014 for the 2nd Circuit Court employees. Commissioner Thompson seconded the motion with all in favor. Please note that this transfer requested funds that have been placed in escrow in the 2014 Adair County budget until reviewed by the Judicial Finance Commission.

The Commission spent the rest of the day attending to County business.

The Adair County Commission adjourned at 4:00 p.m. on October 1, 2014.
