Based on the record and memoranda of the parties and in light of the factors set out in section 50.640.2, the Judicial Finance Commission finds the 2014 circuit court budget requests to Adair and Lewis Counties to be unreasonable. So moved by Commissioner Thompson and seconded by Commissioner Pickens.

Commissioner Thompson moved to accept the list of 2015 Adair County Holidays. Commissioner Pickens seconded the motion. They include: Thursday, January 1, 2015 – New Year’s Day; Monday, January 19, 2015 – Martin Luther King Jr. Day; Thursday, February 16, 2015 – Lincoln Day; Monday, February 16, 2015 – Washington’s Birthday; Friday, May 8, 2015 – Truman Day; Monday, May 25, 2015 – Memorial Day; Friday, July 3, 2015, Independence Day; Monday, September 7, 2015 – Labor Day; Monday, October 12, 2015 – Columbus Day; Wednesday, November 11, 2015 – Veterans Day; Thursday, November 26, 2015 – Thanksgiving Day; Friday, November 27, 2015 – Day after Thanksgiving; Thursday, December 24, 2015 – Christmas Eve (afternoon); and Friday, December 25, 2015– Christmas Day.

After discussions with several citizens of the County, Commissioner Thompson moved to adopt Adair County Commission Resolution # 17- 2014. Commissioner Pickens seconded the motion. This resolution is in opposition of the Ameren Mark Twain Transmission project through Adair County.
