The Adair County Commission convened at 8:30 a.m. on November 12, 2014 in the Courthouse at Kirksville. All Commissioners were present. The Adair County Courthouse was closed on Tuesday, November 11, 2014 in observance of Veteran's Day.

It was determined that in order for the Juvenile Justice Center to make payroll this week, and additional \$500.00 will need to be added to the transfer approved on November 10, 2014. All Commissioners agreed to the additional \$500.00.

At 9:30 a.m., the Commission conducted the bid opening to upgrade the radio equipment for the Adair County Sheriff's Department. Also present for the bid opening was Sheriff Robert Hardwick and David Hurt, Finance Coordinator for the Sheriff's Department.

Command 1 submitted the only bid. Commissioner Pickens opened and read the bid aloud that was in the amount of \$65,805.00. Sheriff Hardwick stated this upgrade would result in the Kirksville Police Department and the Sheriff's Department both operating on digital channels. The Sheriff's Department is currently operating on an analog system. The new system will provide for better reception. Command 1 is the current vendor for the City of Kirksville.

Sheriff Hardwick requested time to look over the bid from Command 1. He wanted the work completed by the end of the year.

Beginning at 1:00 p.m., the Commission spent the rest of the day attending the State Emergency Management Agency (SEMA) Disaster Meeting at the Adair County Annex.

The Adair County Commission adjourned at 4:00 p.m. on November 12, 2014.
