In reference to your letter regarding Booneville Trail in Adair County, we are responding to information regarding Booneville Trail in Adair County.

The Adair County Recorder's Office does not have any documentation regarding relinquishments, deeds and plats that would establish closure, vacation or abandonment of this road. The County Clerk's Office was unable to find any documentation in the Commission minutes referring to the same.

The Adair County Road and Bridge Department has documentation indicating that the first 1/10th of a mile of Booneville Road has been graded three times since 2014 and CART rock applied three different times since 2005. The amount of rock placed on the road indicates that no maintenance has been performed on more than 1/10th of a mile of Booneville Road for several years.

Please disregard if the information regarding Booneville Trail does not pertain to your inquiry.
