

ADAIR COUNTY COMMISSION MINUTES
WEDNESDAY, NOVEMBER 5, 2014
3RD DAY OCTOBER ADJOURNED

The Adair County Commission convened at 8:30 a.m. on November 5, 2014 in the Courthouse at Kirksville. All Commissioners were present.

Adair County Clerk, Sandra Collop, reported Adair County election results from the November 4, 2014 General Election. There was a voter turnout of 41.63 percent.

Results of the winners were as follows:

State Auditor: Tom Schweich (REP) – 3,814 votes; U.S. Representative 6th District: Sam Graves (REP) 3,897 votes; State Senator: Brian Munzlinger (REP) 4,697 votes; State Representative 3rd District: Nate Walker (REP) 3,644 votes; State Representative 4th District: Craig Redmon (REP) 1,165 votes; Associate Circuit Judge: Kristie J. Swaim (DEM) 3,356 votes; Presiding Commissioner of the County Commission: Stanley Pickens (REP) 4,719 votes; Clerk of the Circuit Court: Linda Decker (DEM) 4,782 votes; Clerk of the County Commission: Sandy Collop (DEM) 4,057 votes; Recorder of Deeds: Pat Shoush (REP) 5,013 votes; Prosecuting Attorney: Matt Wilson (DEM) 4,776 votes; opposition. Collector of Revenue: Sonja Harden (DEM) 2,446 votes; Treasurer: Lori J. Smith (REP) 4,982.
