



The parties are ordered to reduce to writing as a written memorandum/Cooperative Agreement, pursuant to Article 6, Section 16 of the Missouri Constitution, the agreement concerning the budget process, funding, expenditures and dismissal of this action and the action pending in the Missouri Supreme Court within seven days and to file a copy of the written agreement with this Court.



SPECIFICATIONS AND BID FORM

The Adair County Sheriff's Office is requesting proposals for health care of the Adair County Detention Center. The Adair County Sheriff's Office reserves the right to accept or reject any and all proposals in part or in whole as deemed in the best interest of the Adair County Sheriff's Office. In determining the most advantageous proposal, the Adair County Sheriff's Office reserves the right to consider quantity, workmanship service, and dependability of the product, manufacturer and dealer accountability, independent of price.

HEALTH CARE FOR DETENTION CENTER

The health care physician or his/her agent shall:

1. Use its best efforts to identify and arrange to provide medical services on behalf of the Adair County Sheriff's Office Detention Center based on an average daily population of 45. The physician(s), his/her agent and the Adair County Sheriff's Office shall set the scheduling of such services upon mutual agreement.
2. During such services the physician(s) shall be under the supervision of the Adair County Sheriff's Office and subject to its rules and regulations. If an agent is providing the physician(s), that agent shall not exercise any control over the performance of the professional and administrative duties of the physician. The agent shall not be responsible for patient care.
3. Physician(s) shall be subject to a background check and shall furnish to the Adair County Sheriff's Office their credentials and shall assist as appropriate in obtaining institutional privileges, namely Northeast Regional Medical Center.
4. Physician(s), at their own expense, in the professional liability insurance policy shall be insured with the dollar limitation of (\$1 million/\$3 million + tail) and terms of the policy while the physician(s) is rendering medical services on behalf of the Adair County Sheriff's Office.
5. Agree to indemnify and hold the Adair County Sheriff's Office harmless if the Adair County Sheriff's Office is made party to any civil, criminal, administrative, or investigative action by reason of any acts or omissions by the physician, against expenses, to include attorney fees, judgments, fines and amounts paid in settlement thereof.
6. Agree to provide on-site/off site mental health services including inmate health screenings with on-call availability 24-hours a day, seven days a week.
7. Agree to provide pharmaceuticals, hospitalization, and medical supplies.
