4. Judge Steele agrees to present four (4) separate detailed budgets to each county by December 1st of each year of this agreement, and shall meet with all counties in the 2nd Circuit in joint session during the month of December of each budget year. The budget shall be detailed as to revenue and expenses, including requests for reappropriation of the year end balances specified in paragraph 5 of this agreement for which consent will not be withhold. These budgets shall be in four categories of the 2nd Circuit; the 2nd Circuit Adminis Justice Center and the Juvenile Justice Services; and the Drug Court. The parties agree that the Adair County Circuit Clerk's budget is not included in this agreeme administrative control of Associate Circuit Judge Kristie Swaim per an Order agreed to by the Court

approximately \$151,000, per the lease/purchase agreement for the Bruce Normile Juvenile Justice
Center through the term of this agreement, which contributions include each county's proportionate e of offort amount of \$134,200.00.
