

ADAIR COUNTY COMMISSION MINUTES
TUESDAY, SEPTEMBER 23, 2014
22ND DAY JULY ADJOURNED

The Adair County Commission convened at 8:30 a.m. on September 23, 2014 in the Courthouse at Kirksville. All Commissioners were present.

At 10:30 a.m., the Elected Official's monthly meeting was held in the Commissioner's Suite of the Courthouse. Attending the meeting were Adair County Presiding Commissioner, Stanley Pickens; Adair County 1st District Commissioner, Carson Adams; Adair County 2nd District Commissioner, Mark Thompson; Adair County Circuit Clerk, Linda Decker; Adair County Treasurer, Lori Smith; and Adair County Assessor, Donnie Waybill. Absent was Adair County Collector, David Erwin; Adair County Recorder, Pat Shoush; Adair County Public Administrator, Rhonda Noe; Adair County Prosecuting Attorney, Matt Wilson, Adair County Sheriff, Robert Hardwick; Adair County Clerk, Sandy Collop; and Adair County Coroner, Brian Noe.

Second District Commissioner, Mark Thompson, reported that David Erwin would be using funds from the Collectors Maintenance Fund to replace storm damaged electronics at the Public Administrators office. He also reported that Tammy Miller, Adair County Deputy Clerk has been chosen by the elected officials to receive the Gary Jones Award. The date for the presentation has yet to be determined.

Mrs. Decker said she needed to move records to the storage unit and asked when that would be possible. First District Commissioner, Carson Adams, reported the new storage building will be ready to use in roughly 2 weeks. He said the plastic to cover the shelves was in and assembly of the cages would begin very soon.

Adair County Assessor, Donnie Waybill reported that he was in need of \$75,000.00 for upgrading the GIS system.

Adair County Circuit Clerk, Linda Decker discussed the need for replacement windows on the third floor.

Second District Commissioner, Mark Thompson, invited the elected officials to have lunch on Wednesday, October 1, 2014. Adair County will be hosting the Northeast Missouri Commissioners & Clerks event for the Northeast District of Missouri. It will be held at the NEMO Fairgrounds beginning at 9:00 a.m. Representatives from Audrain, Chariton, Clark, Knox, Lewis, Lincoln, Macon, Marion, Monroe, Montgomery, Pike, Ralls, Randolph, Schuler, Scotland, Shelby, and Warren Counties represent the Northeast District.


The Commission received a document from Mary R. Russell, Chief Justice of the Supreme Court of Missouri certifying the temporary transfer of Honorable Gary M. Oxenhandler to the 2nd Judicial Circuit (Adair County) in the matter of 2nd Judicial Circuit, Steele vs. Adair County Commission, Case No. 14AR-CV00603.

The Commission spent the rest of the day attending to County business.

The Adair County Commission adjourned at 4:00 p.m. on September 23, 2014.
