

**ADAIR COUNTY COMMISSION MINUTES  
WEDNESDAY, SEPTEMBER 4, 2014  
14TH DAY JULY ADJOURNED**

The Adair County Commission convened at 8:30 a.m. on September 4, 2014 in the Courthouse at Kirksville. Presiding Commissioner Pickens and Commissioner Adams were present.

Commissioner Adams moved that the current budget will reflect an increase in revenue account 905-4-000-600.400 Temporary Loan from General Revenue in the amount of \$15,000.00. There will also be an increase in expense account 101-5-025-700.000 General Revenue (Transfers Out) Temporary Loan to Child Support in the amount of \$15,000.00. The motion was seconded by Presiding Commissioner Pickens. The County has contracted for services from the Missouri Department of Social Services (also known as Multi-County) from January 1, 2014 through December 31, 2016.

As the State of Missouri has not yet disbursed reimbursement funds to Multi-County, the fund is unable to sustain itself. Therefore, this amendment will allow Multi-County to repay this second temporary loan needed to maintain operations of services to Adair County until reimbursement is received from the State of Missouri. Funds will be dispersed on an "as needed" basis.

Commissioner Adams moved to transfer \$5,000 from General Revenue – Transfers Out – Temporary Loan to Child Support Enforcement (101-5-025-700.000) to Child Support Enforcement – Temporary Loan from General Revenue (905-4-000-600.400). The motion was seconded by Commissioner Pickens. This transfer will allow Child Support Enforcement (Multi County) to maintain their operation of services until reimbursement is received from the State of Missouri with eventual repayment to Adair County.

The Adair County Commission adjourned at 4:00 p.m. on September 4, 2014.

Order to Amend 2014 Budget




The contract for services from the Missouri Department of Social Services (also known as Multi-County) has been contracted by the County of Adair from January 1, 2014 through December 31, 2016.
