

**ADAIR COUNTY COMMISSION MINUTES**  
**MONDAY, APRIL 11, 2016**  
**4TH DAY APRIL REGULAR**

The Adair County Commission convened at 8:30 a.m. on April 11, 2016 in the Courthouse at Kirksville. All Commissioners were present.

On Saturday, April 9, 2016, the Commission hosted a program providing Adair County residents a one-time opportunity to bring their old tires to a collection site free of charge. The time was from 9 a.m., to 3 p.m. at the Adair County Road and Bridge Facility at 23016 Potter Trail in Kirksville. The Missouri Vocational Enterprise (MVE) of the Department of Corrections will provide semi-trailers to transport the tires to the MVE's tire processing facility near Jefferson City to be shredded into fuel for power plants.

Many citizens donated their time and efforts to this program. It was estimated that 15,000 tires were taken to the collection site.

The Commission spent the entire day attending to County business.

The Adair County Commission adjourned at 4:00 p.m. on April 11, 2016.

**SCRAP TIRE ROUNDUP PROGRAM**


*For Residents of Adair County Only*

**Purpose:** This program provides Adair County residents a one-time opportunity to bring their old tires to the collection site free of charge. Additionally, the breeding habitat in the rain filled tires for mosquitoes which carry the West Nile Virus and Equine Encephalitis will be removed.

**Time/location:** April 9<sup>th</sup> from 9 a.m. to 3 p.m. at the Adair County Road and Bridge Facility at 23016 Potter Trail.

**Restrictions:** This program is available to *citizens of Adair County only* (including towns/cities within) and will be enforced. DNR has established the following restrictions: Businesses not eligible to participate in this event include tire stores, vehicle repair shops, tire haulers, farm implement dealers, trucking companies, contractors, etc. Foam-filled tires are not accepted.

**Final Destination for the tires:** Missouri Vocational Enterprise (MVE) of the Department of Corrections will provide semi-trailers to transport the tires to the MVE's tire processing facility near Jefferson City to be shredded into fuel for power plants.
