Commissioner Thompson contacted the State Emergency Management Agency (SEMA) to request an extension of the completion deadline for Project Worksheet #00168 and #00171. These worksheets are in junction with Federal Emergency Management Assistance Disaster (FEMA) #4200. The requested date is November 30, 2016.

Commissioner Adams moved to re-appoint Kirksville City Manager, Mari Macomber, to the Regional Planning Commission Transportation Council for an additional two year period. Commissioner Thompson seconded the motion. Mrs. Macomber's appointment ended in February, 2016.

Due to the absence of Presiding Commissioner Pickens, Adair County Road and Bridge Supervisor, Isaiah Curtis, will meet with the Adair County Water Shed District on Stokes Road.

The Commission spent the rest of the day attending to County business.

The Adair County Commission adjourned at 4:00 p.m. on April 19, 2016.
