

**ADAIR COUNTY COMMISSION MINUTES
TUESDAY, APRIL 22, 2014
10TH DAY APRIL REGULAR**

The Adair County Commission convened at 8:30 a.m. on April 22, 2014 in the Courthouse at Kirksville. All Commissioners were present.

At 10:30 a.m., the Elected Official's monthly meeting was held in the Commissioner's Suite of the Courthouse. Attending the meeting were Adair County Presiding Commissioner, Stanley Pickens; Adair County 1st District Commissioner, Carson Adams; Adair County 2nd District Commissioner, Mark Thompson; Adair County Clerk, Sandra Collop; Adair County Circuit Clerk, Linda Decker; and Adair County Assessor, Donnie Waybill. Absent were Adair County Public Administrator, Rhonda Noe; Adair County Recorder, Pat Shoush (attending annual meeting); Adair County Collector, David Erwin (attending annual meeting); Adair County Sheriff, Robert Hardwick; Adair County Prosecuting Attorney, Matt Wilson; Adair County Coroner, Brian Noe; and Adair County Treasurer, Lori Smith.

Mrs. Decker stated that on Friday, April 18, 2014, it was approved that Associate Judge Kristie Swaim be the appointing authority for the Circuit Clerk of Adair County. There was no discussion and Judge Steele abstained from the vote. Mrs. Decker said she works well with Judge Swaim and already the employees of the Circuit Clerk's office are more comfortable with their workplace environment.

Matt Holt has delivered filing cabinets back to the Courthouse that were removed in 2013 when he was given appointing authority for the Circuit Clerk's Office. Mrs. Decker said she was trying to get documentation from Mr. Holt as to his current title so it can be properly documented from whom she received the records. She stated that the returned records will never be certified by anyone in the Circuit Clerk's office due to her not knowing who had access to the records or if any of them were missing. She added that former Circuit Clerk employee, Susan Gall's, case seems to be on hold possibly due to the appointing authority situation.

Mr. Waybill said that he is beginning to plan for the 2014 Board of Equalization (BOE) that will begin in early July.

Commissioner Pickens stated that the County has hired a new Road and Bridge Supervisor who is scheduled to begin work in approximately two weeks.




The meeting ended at 11:30 a.m.
