## ADAIR COUNTY COMMISSION MINUTES WEDNESDAY, APRIL 9, 2014 5TH DAY APRIL REGULAR

The Adair County Commission convened at 8:30 a.m. on April 9, 2014 in the Courthouse at Kirksville. All Commissioners were present.

Adair County Clerk, Sandra Collop, reported successful unofficial results for candidates and questions for the April 8, 2014 Adair County Municipal Election. Successful candidates for R-1 Novinger School District Board Members were Melissa Billington -156, Richard Morelock – 125, and Troy Smith - 105; R-2 Brashear School District Board Members were Traci Mill - 78; Alissa Garlock - 73; and Keith L. Turner - 71; Kirksville R-3 School District Board Members were Judy Duden 1,125; Nan Davis - 1,096; and Greg Gordon - 1,041; City of Brashear Mayor, Curt Platz - 23; City of Brashear Alderman At-Large were Shirlene Hettinger - 24 and Larry L. Childress - 19; City of Kirksville Council Members were Richard "Rick" Steele - 1,097 and Jerry M. Mills – 926; City of Kirksville Question: Shall the City of Kirksville, Missouri continue to impose a sales tax of one-half (1/2) cent for transportation purposes, which will begin on January 1, 2016 - Yes - 1,325 and No - 384; City of Greentop Alderman At-Large were Sam Tarr - 1 and Write-In 1; City of Novinger Alderman at-Large were Tim Cuculich - 66 and Jason Redmon - 65; City of Novinger Question: Shall the City of Novinger continue the 35-cent tax levy on one hundred dollars valuation for general municipal purposes for 4 years in the City of Novinger - Yes -68 and No -7; Village of Gibbs Board of Trustees were Jamie Keller -3; Brandy Pflum - 2; Write - In 1 and Write-In 1; Village of Millard Board of Trustees were Marc McConnell - 5 and Justin Harris - 4; LaPlata Community Fire Protection District Board of Directors were Steve Shipp - 15 and Danny Smithson - 13; Adair County Nursing Home DBA Twin Pines Adult Care Center Board of Directors were Freda May – 1,940 and Write-In 156.

At 10:00 a.m., the Commission met with Adair County Sheriff, Robert Hardwick; Bill King, operations Section Chief and David Hurt, Finance Coordinator, also from the Sheriff's Department. Presiding Commissioner Pickens signed the General Maintenance Agreement with CI3 Integrators to furnish labor and materials expended in the performance of the Electronic Control System within the Adair County Sheriff's Department. The 12-month contract will cover the period January 1, 2014 through December 31, 2014. A signed copy will be returned to the County upon approval of CI3 management.

Sheriff Hardwick presented a letter requesting that the amount due the City of Kirksville from a prior base radio purchase and associated telephone circuit billing be paid from Fund 305 – E-911 Emergency Fund. The Commission agreed. A budget amendment will be prepared to expense \$7,961.10 from Fund 305.

There was discussion on how to approach the repair on the "panic" buttons in the Courthouse. Sheriff Hardwick stated he would like for Command One to install the appropriate hardware. The cost would be approximately \$1,300.00. The panic buttons were not operational due to the Sheriff's Department no longer operating off of the analog system. He said that Judge Steele was aware of the problem and knew he was going to meet with the Commission to resolve the issue. The Commission agreed to have the unit repaired and or replaced. The Sheriff will make the arrangements to accomplish this.
