## ADAIR COUNTY COMMISSION MINUTES TUESDAY, AUGUST 12, 2014 5TH DAY JULY ADJOURNED

The Adair County Commission convened at 8:30 a.m. on August 12, 2014 in the Courthouse at Kirksville. Presiding Commissioner Pickens and Commissioner Adams were present. Commissioner Thompson was absent.

Presiding Commissioner Stanley Pickens and First District Commissioner Carson Adams met with Eric Thomas, Owner of ComputerLand, and Brad Ray, current employee at ComputerLand.

Brad Ray stated that they wanted to discuss some changes that were going to be happening with ETC ComputerLand. Mr. Ray stated that he would be purchasing the Kirksville Office and the name would be changed to Sprocket Technologies. He said that all service pricing and contract fees would remain the same. The current contract could not be sold with the business. The sale will be finalized at midnight on August 29, 2014.

Mr. Ray submitted a new contract for the Commission to consider. If the Commission chose to sign a contract with Sprocket it would run September 1, 2014 to December 31, 2014 and then be renewed on a yearly basis. Mr. Thomas said if the Commission signed a contract with Sprocket Technologies the current contract with ETC ComputerLand would end.

The Commission received a Comprehensive IT Labor Services Agreement and Service Level Agreement from Mr. Ray to review. Mr. Ray will meet with the Commission at a later date to discuss the agreements.

Commissioner Adams moved to amend the 2014 budget to reflect an increase in revenue account 801-4-000-600.600 Law Enforcement General – Insurance claim in the amount of \$1,272.82. There will also be an increase in expense account 801-5-004-600.000 Law Enforcement General – Vehicle Repair/Maintenance in the same amount. Commissioner Pickens seconded the motion. This is the result of a vehicle accident on April 16, 2014, in which a county law enforcement vehicle was struck by another vehicle.

The Commission spent the rest of the day attending to County business.

The Adair County Commission adjourned at 4:00 p.m. on August 12, 2014.
