## ADAIR COUNTY COMMISSION MINUTES WEDNESDAY, AUGUST 6, 2014 3RD DAY JULY ADJOURNED

The Adair County Commission convened at 8:30 a.m. on August 6, 2014 in the Courthouse at Kirksville. Presiding Commissioner Pickens and Commissioner Thompson were present. Commissioner Adams was absent.

Adair County Clerk, Sandra Collop, reported Adair County election results from the August 5, 2014 Primary. There was a voter turnout of 29.34 percent.

Results of the Democratic ballot were as follows:

U.S. Representative 6<sup>th</sup> District: W.A. (Bill) Hedge with 268 votes defeated Edward Dwayne Fields with 136 votes and Gary Lynn Crose with 84 votes. Associate Circuit Judge: Kristie J. Swaim with 586 votes. Clerk of the Circuit Court: Linda Decker with 587 votes. Clerk of the County Commission: Sandy Collop with 597 votes. Prosecuting Attorney: Matt Wilson with 576 votes. Collector of Revenue: Sonja Harden with 555 votes. All local officials did not have opposition.

Results of the Republican ballot were as follows:

State Auditor: Tom Schweich – 2,314 votes with no opposition; U.S. Representative 6<sup>th</sup> District: Sam Graves with 2,338 votes defeated Christopher Ryan with 266 votes, Kyle Reid with 168 votes, and Brian L. Tharp with 138 votes. State Senator: Brian Munzlinger with 2,609 votes and no opposition. State Representative 3<sup>rd</sup> District: Nate Walker with 1,639 votes who defeated John Bailey with 1,109 votes. State Representative 4th District: Craig Redmon with 513 votes and no opposition. Associate Circuit Judge: Josh Meyer with 2,382 votes and no opposition. Presiding Commissioner of the County Commission: Stanley Pickens with 2,521 votes and no opposition. Recorder of Deeds: Pat Shoush with 2,692 votes and no opposition. Collector of Revenue: Mike Brummit with 1,703 votes who defeated William "Bill" King with 1,370 votes. Treasurer: Lori J. Smith with 2,670 votes and no opposition.

Results of the Libertarian ballot were as follows:

State Auditor: Sean O'Toole with 16 votes. U.S. Representative 6<sup>th</sup> District: Russ Monchil with 15 votes. Neither had opposition.

Results of the Constitution ballot were as follows:

State Auditor: Rodney Farthing with 0 votes.

Constitutional Amendments were as follows:

Constitutional Amendment No. 1 (known as the Right to Farm): YES - 2,204 and NO -1,820; Constitutional Amendment No. 2 (known as the Right to Keep and Bear Arms): YES - 2,630 and NO - 1,458; Constitutional Amendment No. 7 (known as a Highway Tax): YES - 1,866 and NO -2,270; Constitutional Amendment No.8 (known as the Veteran's lottery): YES - 2,008 and NO -2,053; and Constitutional Amendment No. 9 (known as Electronic Communications -Unreasonable Search & Seizure): YES - 3,116 and NO - 927.
