This will allow Child Support Enforcement (Multi County) to maintain their operation of services until reimbursement is received from the State of Missouri with eventual repayment to Adair County. Presiding Commissioner Pickens seconded the motion.

At the request of Matt Holt, Court Services Administrator, Commissioner Thompson moved to transfer funds from the Juvenile Justice Center account (907-5-003-902.000) in the amount of \$11,000.00 to the Juvenile Grant Operations account (909-4-000-700.100) so they could make payroll for the two week period ending August 2, 2014 for the 2nd Circuit Court employees. Presiding Commissioner Pickens seconded the motion. Please note that this transfer requested funds that have been placed in escrow in the 2014 Adair County budget until reviewed by the Judicial Finance Commission.
