

**ADAIR COUNTY COMMISSION MINUTES
MONDAY, AUGUST 15, 2016
7TH DAY JULY ADJOURNED**

The Adair County Commission convened at 8:30 a.m. on August 15, 2016 in the Courthouse at Kirksville. Presiding Commissioner Pickens and Commissioner Adams were present. Commissioner Thompson was absent.

The Commission received a filing from Jeremy Crawford – President of the Greentop Fire Association identifying the Greentop Fire Association boundaries within Adair County. The Adair County Commission acknowledges the receipt of the information and has directed the County Clerk to make the information a part of the County Commission records.

Commissioner Adams moved to amend the current budget to reflect an increase in expense account 201-5-008-903.000 Road and Bridge – Equipment Purchases, 3 Graders in the amount of \$401,424.00. Presiding Commissioner Pickens seconded the motion. There will not be a corresponding revenue for this transaction. This is due to the Road and Bridge Department replacing two road graders for use on County roads.

The Commission spent the rest of the day attending to County business.

The Adair County Commission adjourned at 4:00 p.m. on August 15, 2016.
