

ADAIR COUNTY COMMISSION MINUTES
MONDAY, AUGUST 21, 2017
9TH DAY JULY ADJOURNED

The Adair County Commission convened at 8:30 a.m. on August 21, 2017 in the Courthouse at Kirksville. All Commissioners were present. Presiding Commissioner Pickens was present until 12:00 p.m. Commissioner Thompson will continue to be acting Presiding Commissioner during the absence of Presiding Commissioner Pickens.

At 8:45 a.m., the Commission attended the ribbon cutting ceremony at the newly remodeled McDonalds on North Highway Business 63 in Kirksville.

At approximately 9:00 a.m., the Commission held the 2017 Tax Levy Hearing for the Adair County Road and Bridge Department and the Adair County General Revenue Fund. No one from the public attended the hearing.

Discussion was held regarding reinstating the tax levy for General Revenue in tax year 2018. Mrs. Collop presented information regarding the "Sales Tax Revenue Rollback for Tax Levy Year 2017." If a tax had been levied for General Revenue in 2017, it could have generated an additional \$268,000 for the fund. The Commission may consider reinstating the General Revenue tax levy in 2018.

Commissioner King made a motion to approve the 2017 Road and Bridge tax levy at the State allowed rate of 0.2766. Commissioner Thompson seconded the motion. Presiding Commissioner Pickens voted in favor with all Commissioners in favor of the motion. Commissioner King made a motion to leave the 2017 General Revenue tax levy at 0.0000. Commissioner Thompson seconded the motion. Presiding Commissioner Pickens voted in favor with all Commissioners in favor of the motion.

Mrs. Collop stated she had been contacted by the Secretary of State's Office to swear in the Assessor for his new four year term beginning September 1, 2017. Adair County Assessor, Donnie Waybill, had previously been sworn in on January 3, 2017 with all successful candidates elected on November 8, 2016. The Oath for Assessors, however, contains additional verbiage dedicated to assessing real and tangible property in the County. As a result, Mrs. Collop gave the Oath of Office to Donnie Waybill as Adair County Assessor in the Office of the County Clerk on the 18th day of August two thousand seventeen. The original copy will be forwarded to the Secretary of State's Office.


The Adair County Commission adjourned at 4:00 p.m. on Monday, August 21, 2017.
