

**ADAIR COUNTY COMMISSION MINUTES
TUESDAY, AUGUST 25, 2015
11TH DAY JULY ADJOURNED**

The Adair County Commission convened at 8:30 a.m. on August 25, 2015 in the Courthouse at Kirksville. All Commissioners were present.

At 9:30 a.m., the Adair County Commission adopted the following resolution:

BE IT RESOLVED that this meeting be continued in emergency closed session, with closed records and closed votes as permitted by law, for consideration of the following items as authorized by section 610.021.1 of the Missouri statutes:

Discussion under Subsection 1 of the statute for "Legal actions, causes of action or litigation involving a public governmental body and any confidential or privileged communications between a public governmental body or its representatives and its attorneys. However, any minutes, vote or settlement agreement relating to legal actions, causes of actions or litigation involving a public governmental body or" ... and

BE IT FURTHER RESOLVED that if any business not covered by the stated reason or reasons for the closed session is raised during the closed session, that such business will be postponed until this meeting is reopened to the public and the sign for a closed meeting is removed from the doors of the Commission office. Present at the meeting were Presiding Commissioner Pickens; Commissioner Adams; Commissioner Thompson; Adair County Treasurer, Lori Smith; Adair County Clerk, Sandra Collop; and via telephone Adair County Legal Counsel, Ivan Schraeder of the Lowenbaum Partnership, L.L.C. So motioned by Commissioner Thompson and seconded by Commissioner Adams with all in favor at 9:30 a.m. on Tuesday, August 25, 2015.

Closed session ended at 10:19 a.m.

At 10:40 a.m., the Elected Official's monthly meeting was held in the Commissioner's Suite of the Courthouse. Attending the meeting were Adair County Presiding Commissioner, Stanley Pickens; Adair County 1st District Commissioner, Carson Adams; Adair County 2nd District Commissioner, Mark Thompson; Adair County Clerk, Sandra Collop; Adair County Sheriff, Robert Hardwick; Adair County Prosecuting Attorney, Matt Wilson; Adair County Collector, Sonja Harden; and Adair County Treasurer, Lori Smith. Absent were Adair County Recorder, Pat Shoush; Adair County Coroner, Brian Noe; Adair County Public Administrator, Rhonda Noe; Adair County Circuit Clerk, Linda Decker; and Adair County Assessor, Donnie Waybill.


Mrs. Smith had nothing to report.

Mrs. Harden reported she sold one of the five properties offered at the Collector's Back Tax Sale yesterday, August 24, 2015. A sales certificate was issued for the property. A deed for the certificate can be recorded after one year from the date of the sale barring the original property owner does not retire the tax liability on the property. There were no bids on the other properties. Mrs. Harden also stated she was checking into new scanners to enable her office to perform live postings for the upcoming tax season.

Mr. Wilson discussed the status of Laske Trail. He suggested to the Commission to proceed with maintenance as if it were a County road. It has been maintained as a County road all the way past the Finn property for an extended period of time and therefore is now considered part of the County's road system.
