Mr. Howe stated he would take the bids to his office to review them. He recommended that the bid be awarded at 11:00 a.m. on Tuesday, September 3, 2013 in the Commissioner's office. He will have the paperwork prepared for the Commission to sign at that time.

Mr. Howe stated that if the low bid was awarded, they could possibly bring in two crews and build two bridges at a time. They are not, however, allowed to split crews and equipment between multiple sights. The Commission stated they did not want any of the bridges to be torn out for an extended period of time. It is not anticipated there will be a problem acquiring steel at this time.

Commissioner Thompson submitted close out paperwork to the State Emergency Management Agency (SEMA) for Oklahoma Trail.

The Commission spent the rest of the day attending to County business.


The Adair County Commission adjourned at 4:00 p.m. on August 28, 2013.
