The Adair County Commission convened at 8:30 a.m. on August 8, 2016 in the Courthouse at Kirksville. All Commissioners were present.

Adair County Clerk, Sandra Collop, reported Adair County certified election results from the August 2, 2016 Primary. There was a voter turnout of 19.64 percent.

Results of the Democratic ballot were as follows:

U.S. Senator: Jason Kander with 619 votes defeated Cori Bush with 78 votes, Chief Wana Dubie with 53 votes, and Robert Mack with 42 votes. Governor for Missouri: Chris Koster with 669 votes defeated Eric Morrison with 66 votes, Charles B. Wheeler with 49 votes, and Leonard Joseph Steinman II with 12 votes. Lieutenant Governor: Russ Carnahan with 632 votes defeated Winston Apple with 106 votes and Tommie Pierson, Sr., with 33 votes. Secretary of State: Robin Smith with 553 votes defeated Bill Clinton Young with 114 votes and Md Rabbi Alam with 68 votes. State Treasurer: Judy Baker with 557 votes defeated Pat Contreras with 182 votes. Attorney General: Teresa Hensley with 425 votes defeated Jake Zimmerman with 306 votes. U.S. Representative 6th District: Kyle Yarber with 248 votes defeated David M Blackwell with 156 votes, Travis Gonzalez with 119 votes, Edward Dwayne Fields with 68 votes, and Matthew C. McNabney with 62 votes. Commissioner of the County Commission – 1st District: Carson Adams with 423 votes and no opposition. Commissioner of the County Commission – 2nd District: Scott Meredith with 196 votes defeated Frank Vorhees with 98 votes. Assessor: Robert "Bob" Giovannini with 693 votes and no opposition.

Results of the Republican ballot were as follows:

U.S. Senator: Roy Blunt with 1,476 votes defeated Kristi Nichols with 297 votes, Ryan D Luethy with 79 votes, and Bernie Mowinski with 39 votes. Governor: Eric Greitens with 866 votes defeated John Brunner with 460 votes, Catherine Hanaway with 377 votes, and Peter D. Kinder with 251 votes. Lieutenant Governor: Mike Parson with 1,039 votes defeated Bev Randles with 615 votes and Arnie C. - AC Dienoff with 90 votes. Secretary of State: John (Jay) Ashcroft with 1,260 votes defeated Will Kraus with 529 votes and Roi Chinn with 60 votes. State Treasurer: Eric Schmitt had 1,581 votes with no opposition. Attorney General: Josh Hawley with 986 votes defeated Kurt Schaefer with 832 votes. U.S. Representative 6th District: Sam Graves with 1,518 votes defeated Christopher Ryan with 215 votes, and Kyle Reid with 131 votes. State Representative 3rd District: Nate Walker with 1,280 votes and no opposition. State Representative 4th District: Craig Redmon with 438 votes and no opposition. Commissioner of the County Commission – 1st District: William "Bill" King 739 votes and no opposition. Commissioner of the County Commission – 2nd District: Mark L. Thompson with 890 votes and no opposition. Sheriff: Robert "Bob" Hardwick with 1,707 votes and no opposition. Assessor: Donnie Waybill with 1,752 votes and no opposition. Public Administrator: Rhonda Noe with 1,747 votes and no opposition. Coroner: Brian C Noe with 1,785 votes and no opposition.
