#### ADAIR COUNTY COMMISSION MINUTES MONDAY, APRIL 12, 2021 4TH DAY APRIL REGULAR

The Adair County Commission convened at 8:30 a.m. on April 12, 2021 in the Courthouse at Kirksville. All Commissioners were present.

Adair County Clerk, Sandra Collop, reported official results for candidates and issues for the April 6, 2021 Adair County Municipal Election. They are as follows:

Adair County Health Department for Board of Trustees - Four Year Term (Vote for 3) were Brenda C. Higgins – 1,472 votes; Curt Platz – 1,165 votes; Robin Jones Darr – 1,096 votes; Kylene Puckett – 1,085 votes; Jason Soseman – 794 votes; Sharon Colton Tuttle – 737 votes; Theresa Hewitt – 621 votes; Lance Ratcliff – 402 votes and 34 writeins.

Proposition for Adair County: Shall the County of Adair, Missouri, impose a county-wide capital improvement sales tax at the rate of one-quarter of one percent (1/4 of 1%) for the purpose of funding improvements to the Courthouse including but not limited to renovating, repairing, improving, furnishing and equipping of the Adair County Courthouse and its grounds; said tax to be imposed for a period not to exceed the date on which all improvements are completed and all related obligations have been paid in full?

The approval of the proposition will authorize the imposition and collection of one-quarter of one percent sales tax in addition to the other sales taxes provided for by law on all retail sales made in the County which are subject to taxation. YES -1,609; NO -1,276.

School Board Members for R-1 Novinger School District, Adair County (Vote for 2) were Justin R. Klingsmith – 119; Sharon Barnes – 94; Robin Carter – 93; Chante McKim – 87; Matthew Berkus – 50; and Write-ins 0.

Mayor for City of Brashear, Adair County (Vote for 1) were: Eddy Stewart -35 and Chelsey H Johnson -30, Write-in 2.

Proposition A for City of Brashear, Adair County: Shall the fire protection levy remain at \$0.30 the next (4) four years, which is a continuation of an existing tax? YES -35 and NO -3.

Proposition B for City of Brashear, Adair County: Shall the general tax rate for the City of Brashear, Missouri remain at \$1.38 for a period of (4) four years? YES – 34 and NO – 3.

The Commission spent the remainder of the day touring wind farm routes.
