The Adair County Commission convened at 8:30 a.m. on April 26, 2021, in the Courthouse at Kirksville. Presiding Commissioner Shahan and Commissioner Thompson were present. Commissioner King was absent.

At 1:30 p.m., the Commission met with Adair County Collector, Sonja Harden. Mrs. Harden presented the Annual Settlement of Sonja Harden, Collector of Adair County Missouri for the year ended February 28, 2021.

Mrs. Harden stated that taxpayers were respectful of one another during this time of COVID. She placed a drop box outside of the Courthouse that was widely utilized. Total of credits received were \$21,701,599.75 which consisted of current year collections, delinquent collections, abatements collected, protested funds collected and payments received in lieu of taxes. Amount charged off as uncollectable from the 2016 tax year is \$25,923.75.

Mrs. Harden also stated that the recently purchased software for the office has worked well.

The Adair County Commission adjourned at 4:00 p.m. on April 26, 2021.
