ADAIR COUNTY COMMISSION MINUTES WEDNESDAY, DECEMBER 18, 2019 18TH DAY OCTOBER ADJOURNED

The Adair County Commission convened at 8:30 a.m. on December 18, 2019 in the Courthouse at Kirksville. All Commissioners were present.

The Commission met at 9:00 a.m. to discuss the new Multi County Child support contract. Those present were Presiding Commissioner Mark Shahan, 1st District Commissioner Bill King, and 2nd District Commissioner Mark Thompson.

Commissioner Thompson said the only concern with renewing the contract for Adair County to house the Multi-County agency was financial. There is an outstanding loan from General Revenue that was required to pay expenses at the start of the current contract which expires on December 31, 2019. The loan was needed as they are funded by a reimbursement from the State. He stated that as long as they paid off the outstanding debt prior to the end of the year, they could start a new loan with the new contract that begins January 1, 2020. The other Commissioners agreed.

Commissioner Thompson made a motion to approve the new Multi-County contract. Commissioner King seconded the motion. Presiding Commissioner Shahan concurred. All voted in favor of the motion.

At 12:00 p.m., the Commission attended the Courthouse Christmas party at the Adair County Annex.

Presiding Commissioner Shahan signed two grant awards for 2020 Local Law Enforcement Block Grant (LLEBG) from the Missouri Department of Public Safety. The grants, each titiled Mobile Radio Upgrade Project, begin January 1, 2020 with an end date of June 30, 2020. One grant is in the amount of \$9,000.00 and the other \$630.00.

The Adair County Commission spent the rest of the day attending to County business.

The Adair County Commission adjourned at 4:00 p.m. on December 18, 2019.
