The Adair County Commission convened at 8:30 a.m. on February 11, 2019 in the Courthouse at Kirksville. All Commissioners were present. The Adair County Commission attended the County Commissioners Association of Missouri (CCAM) annual meeting in Columbia, Missouri February 5 thru February 8, 2019.

At 9:00 a.m., the Commission met to consider entering into an agreement with the Adair County Humane Society. The Commission had previously met with Krista Baker and Missy Decker on February 4, 2019 to discuss an agreement between the Society and the County.

Commissioner King moved to enter into an agreement with the Adair County Humane Society. Commissioner Thompson stated it was good for the community, but only subsidizing the City. Commissioner Shahan spoke of the original request of \$7,500 and how that had been negotiated down to \$5000. The County needs an agreement for vicious dogs. He suggested the County sign the agreement for one year and see how it goes. It can reviewed again next year. Commissioner Thompson said if they wouldn't be helpful to the people in the County, then we should only give them ½ of what they are seeking. That is what they did for another organization within the County requesting funds. The Humane Society said if they were not full they would take the animals, but according to Commissioner Thompson they are always full. Commissioner King reminded that the contract is not with the City to take vicious animals. Commissioner Thompson thought \$5000 was too much when the people outside the County would not be helped.

Presiding Commissioner Shahan seconded the motion. As discussion had ended, a roll call vote was taken by Adair County Clerk, Sandra Collop:

Presiding Commissioner Shahan - YAY

First District Commissioner, Bill King - YAY

Second District Commissioner, Mark Thompson – NAY with reservations. He would approve with less money.

Motion passed.

The Adair County Commission spent the remainder of the day attending to County business.

The Adair County Commission adjourned at 4:00 p.m.

The Adair County Courthouse will be closed on Tuesday, February 12, 2019 in observance of Abraham Lincoln's Birthday.

The Adair County Commission will reconvene on Wednesday, February 13, 2019 at 8:30 a.m. in the Courthouse at Kirksville.




