Dear Ms. Derks.

We are writing to request a sole source waiver for our workforce development grant, project 2019-WF-07. The wind energy equipment is a requirement for MACC's training lab and will provide necessary hands-on training.

Although there are other companies that make this kind of trainer, the reasonfor requesting a "sole source" is that MACC already has an Amatroi trainer plus
curriculum that was purchased from another college. It does not make sense to
have two different trainers with different curriculum for teaching our classes in
the same location. The instructor would have to make two different lesson
plans and teach everything twice.

The same thing goes for the other equipment from Amatrol and Lab Volt/Festo. It is equipment that is consistent with the equipment MACC is using in their three other training eites including Mexico, Columbia, and on their Mobile lab. It only makes sense that they purchase the same equipment for training so that their curriculum will match across all training labs and teachers/students can move seamlessly from one site to another site. Consistency in technical equipment is important for any type of maintenance that would be required as well.

We are asking that Moberly Area Community College be granted the authority to purchase the items necessary to keep their equipment consistent by using Amatrol and Lab Volt/Festo exclusively.
