ADAIR COUNTY COMMISSION MINUTES TUESDAY, FEBRUARY 26, 2019 8TH DAY JANUARY ADJOURNED

The Adair County Commission convened at 8:30 a.m. on February 26, 2019 in the Courthouse at Kirksville. Presiding Commissioner Shahan and Commissioner King were present. Commissioner Thompson was attending a meeting in Jefferson City.

At 10:30 a.m., the Elected Official's monthly meeting was held in the Commissioner's Suite of the Courthouse. Attending the meeting were Adair County Presiding Commissioner, Mark Shahan; Adair County 1st District Commissioner, Bill King; Adair County Clerk, Sandra Collop; Adair County Treasurer, Lori Smith; Adair County Sheriff, Robert Hardwick; Adair County Recorder, Pat Shoush; and Adair County Assessor, Kent Bryant. Those absent were Adair County Coroner, Brian Noe; Adair County Public Administrator, Rhonda Noe; Adair County Prosecuting Attorney, Matt Wilson; Adair County Collector, Sonja Harden; Adair County Circuit Clerk, Linda Decker; and Adair County 2nd District Commissioner, Mark Thompson.

Ms. Smith expressed thanks to Mrs. Noe, even though she was not in attendance, for providing space to store records from the Treasurer's Office. The storage building at the Road and Bridge Department was again discussed.

Mr. Bryant continues to work with the State Tax Commission (STC). He is organizing a meeting with the STC to discuss the occupancy tax with the County Commission.

Commissioner Shahan stated the gutters on the Courthouse had been inspected. The gutters were full of debris and overflowing causing water to run back into the building. The problem needed to be fixed. Ms. Rohn, Human Resource/Grant Writer, will be looking for grants to help with the expense. The Courthouse structure also needed to be repaired. They have been talking with structural engineers due to a large crack developing in the ceiling of the Courtroom located on the top floor.

Commissioner Shahan also spoke of road concerns. The Commission has met with Ameren regarding damages to roads and they have assured the Commission the repairs would be completed. The Commission is making a strategic plan for the Road and Bridge Department and also for architectural concerns of the Courthouse.

Mrs. Shoush stated that two men had been reviewing information within the Recorder's Office for the wind farm. They have since moved on to Schuyler County.

The Commission sent a letter to the Northeast Missouri Workforce Development Board. It serves as the official letter to appoint Presiding Commissioner, Mark Shahan, to serve as a CLEO Board Member to the Northeast Missouri Workforce Development Board.

The Adair County Commission adjourned at 4:00 p.m.
