The Adair County Commission convened at 8:30 a.m. on February 3, 2020 in the Courthouse at Kirksville. All Commissioners were present.

So motioned by Commissioner Thompson and seconded by Commissioner King. Presiding Commissioner Shahan concurred. All voted in favor of the motion at 1:32 p.m. on Monday, February 3, 2020.
