The Adair County Commission convened at 8:30 a.m. on June 17, 2019 in the Courthouse at Kirksville. All Commissioners were present.

At 1:15 pm, the Commission met with representatives of the Missouri Opioid Crisis Alliance. Present were all three Commissioners, Jeffrey Reeves of Theodora Oringher, and Cathy Nugent of Cooley Public Strategies LLC.

The representatives discussed the ongoing opioid crises and how they were representing different counties and municipalities across the country in the ongoing litigation against the manufacturers. They explained where the different litigations are right now and how they plan on addressing the cases for their clients.

Mr. Reeves explained how fees would be collected from the payout and how the expenses would be divided between all of his clients involved in the suit. They are going to send copies of the retainer agreement along with a copy of the filing from another county and the press release they are using in Clinton County, for the Commissioners' to review. No decisions were made at this time as to if or how the County would be involved in the litigation.

At 2:00 pm, Presiding Commissioner Shahan read a letter from Nancy Pennington, the Executive Director of Adair County SB40 Board. She recommended the three current members, whose terms expire on 7/1/19 be reappointed. The three members are Don Crosby, Julie Lochbaum, and Tyson Treasure. Commissioner Shahan made a motion to reappoint the three members. Commissioner King seconded the motion. Commissioner Thompson concurred. All voted in favor of the motion. Their terms will run from 7/1/19 through 7/1/22.

The Adair County Commission adjourned at 4:00 p.m. on June 17, 2019.
