

**ADAIR COUNTY COMMISSION MINUTES
WEDNESDAY, MARCH 11, 2020
16TH DAY JANUARY ADJOURNED**

The Adair County Commission convened at 8:30 a.m. on March 11, 2020 in the Courthouse at Kirksville. All Commissioners were present.

At 10:10 a.m., Commissioner King moved to approve Ordinance No. 2020-1, An Ordinance of County of Adair, Missouri for utilities on the county right of way. Commissioner Thompson seconded the Motion. Presiding Commissioner Shahan concurred. All voted in favor of the motion.

At 10:15 a.m., the Commission addressed the issue to discontinue land line fees. It was agreed that more investigation needed to be conducted. This will be done a later date.

At 11:00 a.m., Jennifer Wade from AT&T met with 1st District Commissioner Bill King and 2nd District Commissioner Mark Thompson. She wanted to discuss a new project between First Net and AT&T for Band 14 First Responders cell phone service.

She said that with this program First Responders would receive priority phone service during emergencies. She discussed how temporary towers are available in different areas of the state and can be moved quickly to the area during disasters.

1st District Commissioner Bill King explained to Ms. Wade that the county does not have emergency responders and their cell phones are for the Road and Bridge Department. He stated that the Sheriff has his own plan and that she should contact Sheriff Hardwick to see about a meeting with that department. He also told her she might contact Kirksville Police Chief Farnsworth.

Ms. Wade was also given contact information to see about getting on the Local Emergency Planning Commission (LEPC) and Missouri Association of Counties (MAC) agendas so that she could reach several agencies at one time.


The Adair County Commission adjourned at 12:00 p.m. on March 11, 2020.

IN REF. ORDER NO 29 Ordinance No. 2020-1, An Ordinance of County of Adair, Missouri for utilities on the county right of way

COUNTY OF ADAIR, MISSOURI
ORDINANCE NO. 2020-1

An Ordinance of County of Adair, Missouri for utilities on the county right of way.

WHEREAS, The Adair County Commission may designate or find that any utility placed on the county gravel road right of way must meet certain criteria prior to it being placed in the county right of way.

WHEREAS, A running line of at least 12 foot from the center of the roadway will be used on the Adair County gravel roads for the placement of utilities.

WHEREAS, No plowing across county roads is allowed, all boring must be underneath to avoid a settlement trench.

WHEREAS, A minimum depth of 30 inches must be used when plowing in roadway.

WHEREAS, A minimum depth of 60 inches must be used when crossing ditches.

WHEREAS, A minimum depth of 96 inches must be used when boring under roads.

WHEREAS, Utilities must be encased in HDPE pipe under the county road and ditches that are bored.

WHEREAS, Construction must be done using a straight-line placement to connections.


WHEREAS, All construction along county owned asphalt roads will be assessed on a case by case bases.


WHEREAS, All construction must be approved by the County Commission before work may begin.


This Ordinance shall be in full force and in effect from and after its passage and adoption. Should any provision with the Ordinance be adjudged invalid, said determination shall not affect the validity of the balance of this Ordinance.


