ADAIR COUNTY COMMISSION MINUTES MONDAY, MARCH 9, 2020 14TH DAY JANUARY ADJOURNED

The Adair County Commission convened at 8:30 a.m. on March 9, 2020 in the Courthouse at Kirksville. All Commissioners were present.

At 10:00 a.m., the Commission met with members of SkillsUSA. Attending were Marsha Jones, SkilledUSA Advisor with students Abigail Ihnat and Maddie French. SkillsUSA builds leadership skills for career tech students going into trades. One of their top priorities is "service to others." The students wanted to present to the Commission an idea for a community service project.

They explained that as Kirksville was a Purple Heart City, the students wanted to extend to all veterans designated parking spaces in certain parts of the County. Commissioner Thompson told the girls that Adair County was a Purple Heart County. The designated parking spaces would be posted with a sign and the cost of the sign would be \$25.00. They wanted to have two spaces designated in the Courthouse parking lot. The Commission discussed how to install the sign and what would work best for their program. Hopefully, the signs could be installed before Memorial Day weekend. Altogether they hoped to install 50 signs throughout the community. The students will be presenting their idea to the State in April at the Missouri State Technical College.

At 10:15 a.m., the Commission reviewed a Petition for Establishment of Speed Limit. The petition was originally received in the office of the County Commission on October 15, 2019. The proposed speed limit commences in the County Township of Benton in Section 36 on Hedgepath Lane starting at County Road Hwy 6 and ending at County Road KK. The petition contained 12 signatures.

As the petition did not request a specific speed limit, the Commission set the speed at 35 miles per hour as a reasonable speed. Commissioner King moved to set the speed limit to 35 miles per hour. Presiding Commissioner Shahan seconded the motion. Commissioner Thompson concurred. All voted in favor of the motion.

The 11:00 a.m. meeting was cancelled and will be rescheduled for a later date.

At 2:30 p.m., Jon Dwiggins of Howe Company presented permanent and temporary easement paperwork for Bridge 32800162 BRO (50) on Archer Lane.

The Adair County Commission adjourned at 4:00 p.m. on March 9, 2020.
