## ADAIR COUNTY COMMISSION MINUTES MONDAY, MAY 10, 2021 3RD DAY APRIL ADJOURNED

The Adair County Commission convened at 8:30 a.m. on May 10, 2021 in the Courthouse at Kirksville. All Commissioners were present. The Commission was not in session on Wednesday, May 5, 2021.

Commissioner Shahan signed a letter of agreement with Benton & Associates, Inc. to create an exhibit and create an easement detailing additional right of way necessary to maintain the existing roadway at the intersection of Trinity Way and Burns Way, Section Thirty, Township Sixty-four North, Range Fourteen West of the Fifth Principal Meridian, Adair County, Missouri.

At 1:00 p.m., the Commission met with members of CTS Group and the Courthouse Restoration Committee to discuss the renovation of the Adair County Courthouse. CTS will research additional inquiries presented by the group. They hope to return in approximately two weeks to conduct additional analysis of all areas within the building and discuss costs. CTS will contact Charlie Zitnik, Senior Vice President – Public Finance Banker for D.A. Davison & Co., to discuss financing.


