ORDINANCE NO. 2021-2

AN ORDINANCE DETERMINING THE INTENT OF ADAIR COUNTY, MISSOURI, TO REIMBURSE ITSELF FOR CERTAIN CAPITAL EXPTINITURES.

BE IT ORDERED BY THE COUNTY COMMISSION OF ADAIR COUNTY, MISSOURI, AS FOLLOWS:

Section 1. Adair County, Missouri (the "County") has made and/or expects to make capital expenditures on and after the date hereoff in connection with Improvements in the Countbouse forchasing but not limited to removating, repairing, improving, furnishing and equipping of the Adair County Counthouse and its grounds (collectively, the "Project from the prosects of a losse pourclaic agreement, certificates of participation or other obligations to be issued at a future date (collectively, the "Obligations"). The maximum principal amount of the Obligations expected to be issued for the Project is \$5,000,000.

Section 7. This Ordinance shall be in full force and effect immediately from and after its passage and adoption by the County Commission of Adair County, Missourt, this 4th days of May 2021.
