ADAIR COUNTY COMMISSION MINUTES TUESDAY, OCTOBER 27, 2020 10TH DAY OCTOBER REGULAR

The Adair County Commission convened at 8:30 a.m. on October 27, 2020 in the Courthouse at Kirksville. All Commissioners were present.

At 9:00 a.m., the Commission discussed an appointment to the Law Enforcement Restitution Fund (LERF) Board. After discussion, Commissioner King moved to appoint John Ben Grossnickle to the LERF Board. Commissioner Thompson seconded the motion. Presiding Commissioner Shahan concurred. All voted in favor of the motion. Mr. Grossnickle appointment begins immediately.

At 9:15 a.m., the Commission voted to appoint authorized signers when funds needed to be requested for the Moberly Area Community College (MACC) Wind Tech Lab Grant. Commissioner King moved to appoint Mark Thompson, Sonja Harden, and Kent Bryant as authorized requestors for the Community Development Block Grant (CDBG) funds. Commissioner Thompson abstained from the motion. Presiding Commissioner Shahan seconded the motion. Both voted in favor of the motion.

Commissioner Thompson then moved to appoint Bill King as an authorized signer when funds needed to be requested for the Moberly Area Community College (MACC) Wind Tech Lab Grant. Commissioner King abstained from the motion. Presiding Commissioner Shahan seconded the motion. Both voted in favor of the motion.

The Wind Tech Grant was awarded to the County of Adair beginning September 2, 2020. It was not announced to the public until after September 25, 2020. The grant award is for \$480,688 with \$452,585 for Machinery/Equipment; \$28,103 for Administration; and \$5,000 In-Kind matching funds. The fully executed grant agreement is on file in the office of the County clerk.

At 1:30 p.m., the Commission met with Adair County Prosecuting Attorney, Matt Wilson; Sheriff Robert Hardwick: newly elected Sheriff as of January 1, 2021, Eldon Grissom; Administrative Section Chief/Financial Director, Danica Collinge; and Adair County Clerk, Sandra Collop.

Sheriff Hardwick stated that one of the Sheriff's Department employees will be retiring December 31, 2020. Her replacement is currently employed in the Prosecuting Attorney's office and will be transferring to the Sheriff's Department soon to be trained by the outgoing employee. The Sheriff's Department did not have funds to pay the salary of the additional employee for the remainder of the year. Mr. Wilson stated he could continue paying for his employee (that would be transferring to the Sheriff's Department) however, he was concerned of the additional cost to his budget if a replacement was hired in his department. Several ideas were introduced if the possibility did occur as to how the additional funds could be recouped by the Prosecuting Attorney's office. Monies from the Law Enforcement Restitution Fund Board for the additional salary was also discussed. All parties agreed to continue the discussion if the need arises before the end of the year.

At 2:30 p.m., the Commission acted on applications from organizations within Adair County for funding from the Coronavirus Aid, Relief and Economic Security (CARES) Act.
