The Adair County Commission convened at 8:30 a.m. on August 8, 2018 in the Courthouse at Kirksville. All Commissioners were present.

Adair County Clerk, Sandra Collop, reported Adair County unofficial election results from the August 7, 2018 Primary. Voter turnout was 33.26 percent.

Note: Statutory Measure Proposition A for Missouri - Referendum ordered by Petition - appeared on all ballot types. Results are listed at the end of the election results.

United States Senator, Adair: Josh Hawley with 1,642 votes defeated Tony Monetti with 190 votes, Austin Petersen with 191 votes, Fred Ryman with 69 votes, Christina Smith with 205 votes, Kristi Nichols with 324 votes, Bradley Krembs with 27 votes, Ken Patterson with 92 votes, Brian G. Hagg with 43 votes, Courtland Sykes with 58 votes, and Peter Pfeifer with 83 votes. State Auditor for Missouri, Adair: Saundra McDowell with 1,103 votes defeated Kevin M. Roach with 525 votes, David Wasinger with 490 votes, and Paul Curtman with 387 votes. United States Representative in Congress for 6th District, Adair: Sam Graves with 2,714 votes and no opposition; State Senator for 18th District, Adair: Nate Walker with 1,659 votes defeated Lindell F Shumake with 121 votes, Craig Redmon with 543 votes, and Cindy O'Laughlin with 1,072 votes. State Representative for 3rd District, Adair: Danny Busick with 1,702 votes and no opposition. State Representative for 4th District, Adair; Greg Sharpe with 645 votes and no opposition; Presiding Commissioner of the County Commission for Adair County, Adair: Mark Shahan with 1,433 votes defeated Molly McKim Balliew with 337 votes; Thomas Daugherty with 359 votes; Sam F. Berendzen with 639 votes; Myles G. Kelly with 33 votes; and Alan Whittom with 479 votes. Clerk of the Circuit Court for Adair County, Adair: Angie Sullivan with 2,564 votes and no opposition; Recorder of Deeds for Adair County, Adair: Pat Shoush with 2,813 votes and no opposition. Statutory Measure Proposition A for Missouri, Adair: Referendum ordered by Petition -

Do the people of the state of Missouri want to adopt Senate Bill 19 ("Right-to-Work") as passed by the general assembly in 2017, which prohibits as a condition of employment the forced membership in a labor organization (union) or forced payments of dues in full or pro-rata (fair-share); make any activity which violates employees' rights illegal and ineffective; allow legal remedies for anyone injured as a result of another person violating or threatening to violate employees' rights; and which shall not apply to union agreements entered into before the effective date of Senate Bill 19? State and local government entities expect no costs or savings. YES - 1,934 votes; NO - 2,659 votes.

The August 7, 2018 Primary Election will be certified on August 10, 2018 and results could vary.


The Adair County Commission spent the day attending to County business.
