

The mortgage payment was now the responsibility of Adair, Knox, and Lewis Counties. Judge Steele questioned the amount of insurance premiums charged to the Second Judicial Circuit for their operations and felt they were paying for coverages they did not need. Mr. Williams thought it would decrease their expense if some coverages were removed. Mr. Williams had spoken to the Deputy Attorney General who stated that some coverages were already being provided by the State. Mr. Schraeder suggested the Second Circuit supply a written opinion from the Deputy Attorney General's office. Judge Steele had already obtained an e-mail stating this and would supply it to the Counties.

The topic of not having current grant contracts on file in the County Clerk's office was discussed. Mr. Schraeder stated Adair County's policy was to budget only for grant monies supported by a signed contract. This is how the grants will be documented in the Adair County budget.

Ms. Miller requested that the final Second Judicial budget be submitted using the template provided by the Missouri State Auditor's Office. That would follow compliance with the Auditor's office.

The budget hearing concluded at 2:45 p.m.

At 2:00 p.m., Presiding Commissioner Evan Glasgow, brought the required budget hearing of the Second Judicial Circuit – Adair, Knox, and Lewis Counties – to order. Present at the meeting was the Adair County Commission, Adair County Treasurer, Adair County Clerk and Deputy County Clerk, Knox County Commission, Knox County Clerk, Lewis County Commission, Lewis County Clerk, Legal Counsel for Adair, Knox, and Lewis Counties, Ivan Schraeder; Second Circuit Judge, Russell Steele; and Court Services Administrator, Pat Williams. Echo Menges, reporter for the Edina Sentinel was also present.

Judge Steele began by introducing Mr. Williams to the group. He explained he had started the position of Court Services Administrator in March, 2015. He was learning the job and working through his first budget process. He has balanced the Juvenile's account through December 1, 2015 and then projected out revenues and expenses for December. He has evaluated 2015 and looked back over the past 6 -8 years to obtain knowledge as to the costs associated with the Second Circuit. He stated that as of January 1, 2016 one of the juvenile officer positions would be eliminated, that 60% of the revenue was generated from residential care fees with a population of 11-12 residents per day house for abuse and neglect, and they had a Christmas party on Christmas Eve. Mr. Williams stated that on the detention side of the facility, the population averaged 7 detainees per day, but today there was only 6. Detention services were also for abuse and neglect cases.
