## ADAIR COUNTY COMMISSION MINUTES **TUESDAY, FEBRUARY 11, 2014** 5TH DAY JANUARYADJOURED

The Adair County Commission convened at 8:30 a.m. on February 11, 2014 in the Courthouse at Kirksville. All Commissioners were present.

Discussion was held to appoint Joe Nicol as the "Maintenance Foremen" of the Courthouse. There are currently two individuals hired as custodians and the appointment will designate supervisory duties. Commissioner Thompson moved to appoint Joe Nicol as the Maintenance Foreman. Commissioner Adams seconded the motion will all in favor. Mr. Nicol will be informed of his new title.

Due to billing problems with WEX, a provider of fuel at the local Sinclair station, it was agreed to discontinue use of that credit card. Mr. Nicol was present for the decision and also agreed. All fuel for the County vans will now be purchased using the County's credit card. Mr. Nicol agreed to complete the State paperwork for reimbursement of the fuel tax.

Discussion was held with Adair County Clerk, Sandra Collop, regarding the bonding requirements for the County Collector and County Treasurer. The Commission noted that the statutory requirements of \$750,000 for the Collector were no longer adequate. As David Erwin, the current County Collector, had announced his intention not to seek another term of office, it would be the opportune time to increase the bond requirement beginning with the new 2015 term. Mrs. Collop stated that beginning with candidate filing on February 25, 2014, the State was requiring candidates filing for Collector and Treasurer to produce documentation stating they had been pre-certified by a bonding company in the amount required by the County in which they were filing. This new provision was enacted due to certain individuals who had filed and were elected but unable to take office due to their inability to get bonded.

Commissioner Adams moved to increase the bonding requirements for the Adair County Collector to \$1,000,000 with the next term beginning March 1, 2015. Commissioner Thompson moved to second the motion with all in favor. It was determined that the current bond requirement of \$120,000 increasing to \$3,000,000.00 annually between November 1st and January 31st was satisfactory for the office of Adair County Treasurer.

Steven Re' requested a copy of the Petition for Review of FY 2014 Budget of Adair County, Missouri when it has been submitted to the Judicial Finance Commission of the State of Missouri. The petition will be filed on or before February 14, 2014, by Adair County Counsel, Ivan Schraeder. Mr. Re' will pick up the copy on Tuesday, February 18.

Commissioner Thompson moved to officially appoint Mari Macomber, Kirksville City Manager, to the Regional Planning Commission Transportation Council. Commissioner Adams seconded the motion with all in favor.

The Commission spent the rest of the day attending to County business.

The Adair County Commission adjourned at 4:00 p.m. on February 11, 2014.

On February 12, 2014, the Adair County Commission will attend the Commissioner's Annual Conference that will be hosted this year in Columbia, Missouri. The conference will end on February 14, 2014.

The Adair County Courthouse will be closed on Monday, February 17 in observance of President's Day. The Adair County Commission will reconvene at 8:30 a.m. on Tuesday, February 18, 2014.
