1. Introduction and Background Information
1.1. The Missouri Department of Social Services. Family Support Division (Department) hereby enters into this cooperative agreement with the County of Adair (Dereinafter 'County') by their respective office holders, including the Proceeding Attorney. Circuit Glerk and Presiding Commissioner for the reimbursement of IV-D child support services.

a. For the purpose of this cooperative agreement the term 'contrast' shall mean the same as 'cooperative agreement'.

c. 1.4. The Department under Title IV-O of the Social Security Act, and under section \$44.400, RSNo, has been delegated the responsibility for the development and administration of a strengthening Missouri families, Indiana, and the Administration of a strengthening through the Offices of the various Circuit Glerks within the State of Missouri.
