Any such changes made to this agreement require the written approval of each party's Authorized Official. 4) Each party shall be responsible for its negligent acts or omissions and the negligent acts or omissions of its employees, officers, or directors, to the extent allowed by law. 5) Either party may terminate this agreement with thirty days written notice to the appropriate party's Administrative Contact, as shown in Attachment 3. If applicable, University shall pay Collaborator for termination costs as allowable under OMB Circular A-87, OMB Circular A-21, OMB Circular A-122, or the Federal Acquisition Regulation, whichever applies. 6) This agreement is subject to the terms and conditions of the Prime Award, Project No. 14-154-AL-062, and other special terms and conditions. 7) This agreement shall be governed and construed in accordance with the laws of the State of Missouri.
