

ADAIR COUNTY COMMISSION MINUTES
MONDAY, FEBRUARY 8, 2016
4TH DAY JANUARY ADJOURNED

The Adair County Commission convened at 8:30 a.m. on February 8, 2016 in the Courthouse at Kirksville. All Commissioners were present.

Adair County Clerk, Sandra Collop, reported that she had delivered a third floor bathroom key to Judge Steele's Secretary, Marsha Pickett. Mrs. Collop will send a copy of the paperwork recording the transfer of the key to Adair County Legal Counsel, Ivan Schraeder.




Mrs. Collop also stated that a representative from the County's liability insurance carrier had received a phone call from Pat Williams, Court Administrator for the 2nd Judicial Circuit. Mr. Williams wanted to remove insurance coverages from the vehicles which are owned by the County but being used by the Juvenile Justice Center. The ownership of the vehicles was determined in the December, 2014 Settlement Agreement between Judge Steele and the Commission, County Clerk, and Treasurer. She stated that per the insurance carrier the owner of the vehicle(s) was the only one who could decrease or remove coverages from a vehicle. The Commission agreed that the vehicles would remain with the current insurance carrier. The carrier will call Mr. Williams and speak with him regarding the Commission's decision.


Per Section 205.100 RSMo, First District Commissioner, Carson Adams, moved to appoint Jim LeBaron as the Director of the Public Health Council for 2016. Second District Commissioner, Mark Thompson, seconded the motion with all in favor.


The Commission spent the rest of the day attending to County business.

The Adair County Commission adjourned at 4:00 p.m. on February 8, 2016.
