

# ADAIR COUNTY COMMISSION MINUTES TUESDAY, JULY 19, 2016 7TH DAY JULY REGULAR

The Adair County Commission convened at 8:30 a.m. on July 19, 2016 in the Courthouse at Kirksville. Commissioner Adams and Commissioner Thompson were present. Presiding Commissioner Pickens was out of town.

The Commission spoke telephonically with Bill Bray of TelePlus Solutions. The Commission had asked Mr. Bray to obtain bids for the operation of the telephone system. He obtained bids from the current provider, AT & T, and from Cable One. Mr. Bray stated that for comparable service, A T & T provided service at a cost substantially less than Cable one. He attempted to obtain a third bid, but was unable to find another provider within the area. When asked about the difference in price, Mr. Bray stated that Cable One was not as cost efficient on the commercial side.


The Commission stated they would review the bid and make a determination after discussion with Presiding Commissioner Pickens.

The Commission received the fully executed agreement for the Memorandum of Agreement for Assembling and Compiling Geographic Information System (GIS) Data for the State of Missouri.

The Commission spent the rest of the day attending to County business.

The Adair County Commission adjourned at 4:00 p.m. on July 19, 2016.
