

ADAIR COUNTY COMMISSION MINUTES
MONDAY, JUNE 5, 2017
14TH DAY APRIL REGULAR

The Adair County Commission convened at 8:30 a.m. on June 5, 2017 in the Courthouse at Kirksville. All Commissioners were present. Presiding Commissioner Pickens was present until 12:00 p.m. Commissioner Thompson will continue to be acting Presiding Commissioner during the absence of Presiding Commissioner Pickens.

At 9:00 a.m., the Commission traveled to the Schuyler County Courthouse to meet with the Schuler County Commission.

Discussion was held regarding BRO 50, the bridge replacement on County Line Way. They discussed with the Schuyler County Commission the need to approach the condemnation process to obtain the land needed to construct the bridge. Ms. Gravett has been discussing the situation with the Adair County Prosecuting Attorney, Matt Wilson.

On the way back to Adair County, the Commission inspected Hungry Hollow Road to observe the repairs to the City property by Hazel Creek Lake. It appeared that all repairs had been completed by the Adair County Road and Bridge Department along with reseeding of the area.

At 10:45 a.m., the Commission attended an informational meeting at the Adair County Annex. Jay Ashcroft, Missouri Secretary of State, discussed the #ShowIt2Vote process that came into law June 1, 2017 due to legislation being passed in the November, 2016 general election regarding voter-id requirements. The meeting lasted approximately one hour as he entertained questions from the public. Mr. Ashcroft will travel to all parts of the State today to discuss the new #ShowIt2Vote process.

At 1:30 p.m., the Commission met with members of the Adair County Sheriff's office to conduct a bid opening for repairs to the roof of the Adair County Jail. Present along with Commissioner Thompson and Commissioner King were Dave Hurt and John Axsom of the Sheriff's Department, and Jami Seaton from SRI Contractors. Bids were opened and read aloud by Commissioner King. Bids were received as follows:

The Sheriff's Department will review the bids and give their recommendation as to the award in the near future.
