

**ADAIR COUNTY COMMISSION MINUTES**  
**WEDNESDAY, NOVEMBER 7, 2018**  
**3RD DAY OCTOBER ADJOURNED**

The Adair County Commission convened at 8:30 a.m. on November 7, 2018 in the Courthouse at Kirksville. All Commissioners were present.

Adair County Clerk, Sandra Collop, reported Adair County election results from the November 6, 2018 General Election. There was a voter turnout of 60.36 percent.

Results of the winners were as follows:

Senator for United States, MO: Josh Hawley (REP) 4,937 votes; State Auditor: Sandra McDowell (REP) 4,572 votes; U.S. Representative 6<sup>th</sup> District: Sam Graves (REP) 5,547 votes; State Senator for 18<sup>th</sup> District: Cindy O'Laughlin (REP) 5,136 votes; State Representative 3<sup>rd</sup> District: Danny Busick (REP) 3,660 votes; State Representative 4<sup>th</sup> District: Greg Sharpe (REP) 1,491 votes; Circuit Judge for Circuit 2: Russell Steele (DEM) 6,524 votes; Associate Circuit Judge: Kristie J. Swaim (DEM) 5,451 votes; Presiding Commissioner of the County Commission: Mark Shahan (REP) 5,123 votes; Clerk of the Circuit Court: Linda Decker (DEM) 4,637 votes; Clerk of the County Commission: Sandy Collop (DEM) 7,091 votes; Recorder of Deeds: Pat Shoush (REP) 7,169 votes; Prosecuting Attorney: Matt Wilson (DEM) 6,943 votes; Collector of Revenue: Sonja Harden (DEM) 6,990 votes; Treasurer: Lori J. Smith (REP) 7,055.
