The Adair County Commission convened at 8:30 a.m. on November 7, 2012 in the Courthouse at Kirksville. All Commissioners were present.

Steele (DEM); County Commissioner – First District, Carson Adams (DEM); County Commissioner – Second District, Mark Thompson (REP); Sheriff, Robert "Bob" Hardwick (REP); Assessor, Donnie Waybill (REP); Public Administrator, Rhonda Noe (REP); Coroner, Brian C Noe (REP); Surveyor, Write-In; Constitutional Amendment 3 – NO; Proposition A, Proposition B, and Proposition E – Yes; Missouri Supreme CT, Judge Draper – Yes; Judge Western District, Martin – Yes; Judge Western District, Newton – Yes; Judge Western District, Witt – Yes; County Wide Tax Proposition – Yes; and City of Kirksville Proposition – Yes.
