

**ADAIR COUNTY COMMISSION MINUTES
TUESDAY, OCTOBER 29, 2013
12TH DAY OCTOBER REGULAR**

The Adair County Commission convened at 8:30 a.m. on October 29, 2013 in the Courthouse at Kirksville. All Commissioners were present.

The Commission met with Adair County Prosecuting Attorney, Matt Wilson, Adair County Treasurer, Lori Smith, and Adair County Clerk, Sandra Collop to discuss the future of the Multi County. Multi County provides juvenile services for six counties that includes Clark, Lewis, Scotland, Knox, Schuyler, and Adair.

Mr. Wilson reported that Peter Danielson, the attorney who handles court cases for all six counties and child support cases, resigned from his position. He and Clark County Assistant Prosecuting Attorney, John Moon, had a disagreement concerning resumes of applicants to replace secretary, Kay Biggerstaff. Mrs. Biggerstaff had recently been appointed by Governor Jay Nixon to complete the current term of the Lewis County Circuit Clerk. As a result, Mr. Danielson had resigned his position with Multi County.

Mr. Wilson spoke of possible decreases in funding from the State for Multi County which could possibly increase cost to Adair County who is currently housing the financial side of Multi County. Mr. Wilson stated there was a possibility of combining the Multi County duties with those of the Juvenile Office of Adair County which is the largest of the Counties served. There is also the possibility that Mr. Danielson will reconsider his resignation. Jason Lamb of the Missouri Office of Prosecution Services (MOPS) will be in Adair County tomorrow and Mr. Wilson will discuss the situation with Mr. Lamb. Mr. Wilson said he would keep the Commission informed of any suggestions that are provided to him.

At 11:22 a.m., the Adair County Commission adopted the following resolution:

BE IT RESOLVED that this meeting be continued in closed session, with closed records and closed votes as permitted by law, for consideration of the following items as authorized by section 610.021 of the Missouri statutes:

Discussion under Subsection 1 of the statute for "Legal actions, causes of action or litigation involving a public governmental body and any confidential or privileged communications between a public governmental body or its representatives and its attorneys. However, any minutes, vote or settlement agreement relating to legal actions, causes of actions or litigation involving a public governmental body or" ... and

Discussion under Subsection 3 of the statute for "Hiring, firing, disciplining or promoting of particular employees by a public governmental body when personal information about the employee is discussed or recorded" ... and

Discussion under Subsection 13 of the statute for "Individually identifiable personnel records, performance ratings or records pertaining to employees or applicants for employment" ...and
